



Each member shall pay Annual Dues to renew Club Membership

Dues shall be due by the first day of January of each year; dues not received by that date will cause the removal of that member from all voting lists and membership privileges. 'Household Memberships' shall be defined as two adults living within the same household, each receiving one vote.

Membership renewal

Single adult membership renewal shall be \$35.00; **Household membership** renewal shall be \$40.00; **Foreign membership** renewal shall be \$40.00 and shall have no voting privileges, however North American members are NOT considered as 'Foreign Memberships'. **Junior membership** renewal (with or without Household membership) is free.

Dues are payable in US Funds only and payments must be postmarked prior to January 1. Any renewals received with a postmark after December 31, 2009 will require a \$10.00 late fee in addition to the regular renewal. Any dues postmarked after March 1, 2010 shall be returned and a new application will then be necessary along with two sponsor forms to re-apply for membership.

Life members are not required to pay dues, but any personal contribution toward the BCOA operational expenses is greatly appreciated.

BCOA dues are not tax deductible per the IRS
