**Single adult** membership renewal shall be \$35.00. **Household membership** renewal shall be \$40.00. 'Household Memberships' shall be defined as two adults living within the same household, each receiving one vote. **Foreign membership** renewal shall be \$40.00 and shall have no voting privileges, however North American members are NOT considered as 'Foreign Memberships'. **Junior membership** renewal (with or without Household membership) is free. **Life members are not required to pay dues**, but any personal contribution toward the BCOA operational expenses is greatly appreciated. BCOA dues are **not** tax deductible per the IRS.

Dues are payable in US Funds only and payments **must be postmarked prior to January 1, 2012**. Any renewals received with a postmark after December 31, 2011 will require a \$10.00 late fee in addition to the regular renewal. Any dues postmarked after March 1, 2012 shall be returned and a new application will have to be submitted, along with two sponsor forms to re-apply for membership.
